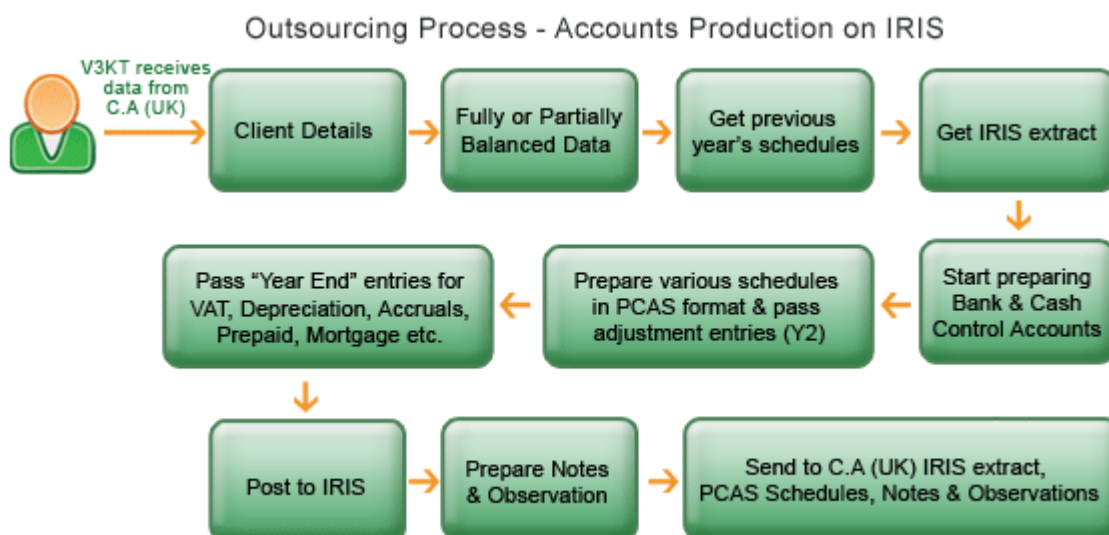

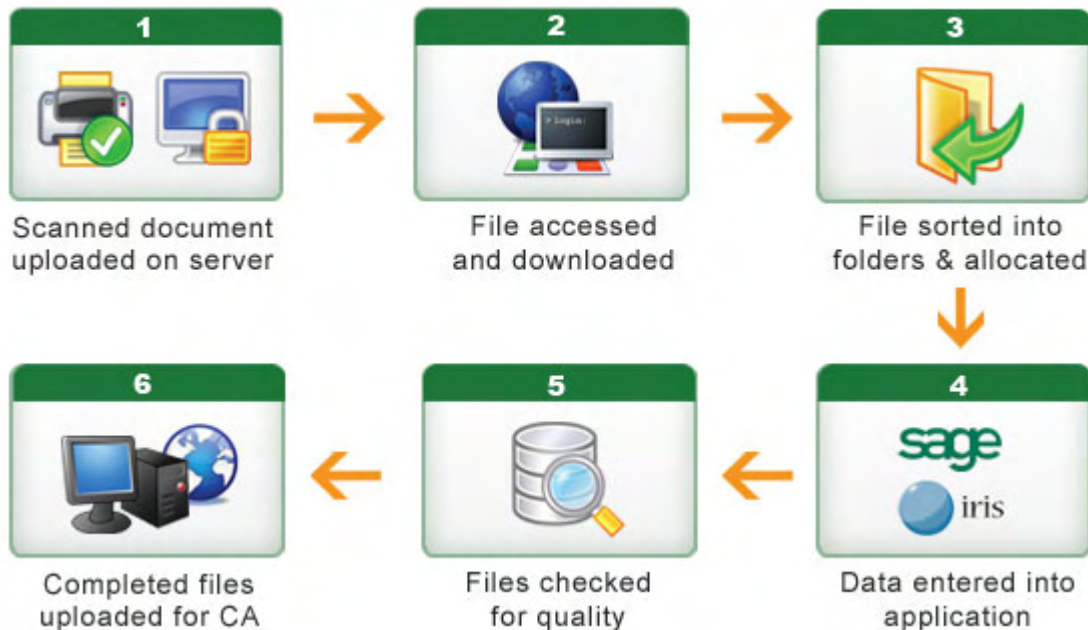


B. Book-Keeping Services
